#### **Activities:**

#### **Drumheller Flood Mitigation**

Back in November 2019, Drumheller's Council approved Bylaw 15.19 which established the Drumheller Resiliency and Flood Mitigation Office. Darwin Durnie was also appointed as Flood Mitigation Officer, and Council also created an advisory committee to oversee the program implementation.

The responsibilities of the program will be to administer and manage flood readiness, oversee drought management and direct infrastructure projects related to the flood resiliency project. The general mandate of the group is to be "proactive and change the channel on flood readiness by developing a sustainable plan to protect Drumheller from future flooding."

This program is being funded by the Federal Disaster Mitigation and Adaptation Fund, the Alberta Community Resilience Program and the Town of Drumheller. These funds are aimed to help Canadian communities mitigate future flooding disasters and support the design and construction of projects that protect critical infrastructure from flooding and drought, and to help ensure public safety.

Palliser has been participating on this committee for some time, but only recently have we provided direct input to the committee. We have provided access for the committee members to a full web map service for the Town of Drumheller, and we have been in active discussions on the development of a Municipal Development Plan (MDP) and updated Land Use Bylaw (LUB) for the Town.

Some consulting funding is available within the program to assist Palliser in getting these documents upgraded within a very tight timetable. The Committee meets on a weekly basis as developments occur, and at a meeting scheduled in Calgary on February 11<sup>th</sup>, we will be meeting with 02 Planning + Design Inc. to develop a term of reference for the planning documents required. The goal will be to align Drumheller's planning framework with the objectives of the Flood Planning group.

#### IDP UPDATE

With the passing of Bill 25 Red Tape Reduction Act, the Municipal Government Act no longer requires municipalities to adopt an intermunicipal development plan with each other if they agree that they do not require one. The majority of our municipal shareholders have chosen to opt out of completing IDPs with their municipal neighbours where they feel an IDP is not necessary.
