

FUNDING:

PRMS operates under a user pay principle. Sources of revenue include; shareholder requisitions, administration of safety codes, planning and consulting fees.

STAFF:

CEO/Director of Planning , Executive Assistant, 1 Planner, 1 Subdivision Planner, GIS Coordinator, and 1 Safety Codes contract personnel.

STRUCTURE:

General membership meetings once per year.

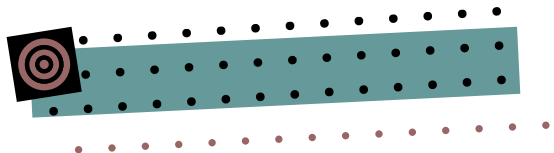
HISTORY:
